SECTION 1 - Introduction to Two Mile Ash School

Two Mile Ash School is part of Inspiring Futures through Learning (IFtL). IFtL is a Multi-Academy Trust with the vision to develop a family of schools whose purpose is to inspire the futures of children through learning. Established in 2016 by educationalists, children are at the heart of all we do.

IFtL is based centrally in the rapidly expanding Milton Keynes and has many schools in the trust. Each school has their own unique identity and personality. However, we all share the same core goal: to strive to provide a world class education provision for all children.

At IFtL, independent, articulate thinkers and learners have the confidence to achieve their ambitions. The team is constantly in the pursuit of development and excellence every day. Teachers of the future come to us to learn and develop their careers and contribute to a vibrant and dynamic community where the development of a child is not only about achieving good results, it is about creating amazing people.

Two Mile Ash school is officially designated as a co-educational, non-selective, Academy School, catering for children from Year 3 (seven years) to Year 6 (eleven years). Children usually enter the school in September following their seventh birthday, and leave at the end of the school year in which they are eleven. School sessions begin at 8.40, (with children allowed to come into the classroom from 8.30am) and end at 3.30 pm. Children will enjoy a morning break time and a lunch period during the school day.

Admission Policy

September 2020/21

Two Mile Ash School is an Academy School and, as such, the Governing Body of the school and not Milton Keynes Local Authority (the LA), is responsible for deciding on admissions. The dates and process of applications will be in accordance with the Coordinated Admissions Scheme, details of which will be published by the LA.

Children with Statements of Special Educational Needs naming Two Mile Ash School will be given priority for admission at the normal transfer point at 7+.

The number of intended admissions currently stands at 170. Two Mile Ash School will admit pupils aged 7 to 11 years of age (i.e. Years 3, 4, 5 and 6) based on the following admissions criteria:

- a. Children in Care.
- b. Pupils who live in the defined area; Great Holm, Two Mile Ash and Crownhill to the north of Monro Avenue and Marley Grove.
- c. Children of staff at Two Mile Ash School where the member of staff has been employed, on continuous service, at the school for 2 or more years, at the time at which the application for admission is made
- d. Pupils attending a school which is in the defined area served by the school, i.e. Ashbrook or Holmwood Schools.
- e. Pupils with a sibling attending the school at the time of admission. A sibling is a brother or sister, which for admission purposes means brothers and sisters of whole or half blood or any other child (including an adopted child) who permanently resides at the same address and for who the parent also has parental responsibility. For multiple births, in cases where there is one remaining place available and the next child on the waiting list is one of a twin, triplet or other multiple birth group, both twins would be admitted (or all siblings in the case of multiple births) even if this goes above the admission number for the school.
- f. Children living outside the defined area.

If the school is oversubscribed, places will be allocated according to the shortest direct route (i.e. straight line) of the pupil's home address to the main entrance of the school, using a computerised measuring system, with those living closer to the school receiving the higher priority.

Secondary School Transfer

At the end of the school year, in which a Two Mile Ash child becomes eleven, transfer to secondary school takes place.

Secondary Education in Milton Keynes is based upon the comprehensive pattern, and Two Mile Ash children who live in our reserved area normally transfer to Denbigh School or The Hazeley Academy.

It also includes the 'hidden curriculum'; what the children learn from the way they are treated and expected to behave. We aim to teach children how to grow into positive, responsible people, who can work and co-operate with others while developing knowledge and skills, so that they achieve their true potential.

Values

Our school curriculum at Two Mile Ash is underpinned by our common ethos and shared values that we hold dear. The curriculum is the means by which the school achieves its objective of educating children in the knowledge, skills and understanding that they need in order to lead fulfilling lives.

Student Voice

It is our duty to foster an environment where children feel they are making a difference. The Student Council are a group of children from Year 3, 4, 5 and 6 who have been voted by their fellow year group to represent them as the Two Mile Ash Student Council. To be a part of the Student Council, pupils write a manifesto which states how they could make Two Mile Ash an even better place. Pupils present manifestos to their year group in an assembly and then each individual votes for the boy and girl they think would do the best job for the year group. Being part of the Student Council is hard work and great fun, but most importantly we can make a difference!

Student Council have an overarching responsibility to monitor the impact of other pupil voice groups including, 'Sports Captains, 'Junior Librarians, 'Science Leaders' and 'Leaders', we are always looking to develop our pupil voice groups with new ideas.



Section 3 - Nurturing the Best in Each Other

Safeguarding Children

At Two Mile Ash, there exists an atmosphere in which children feel secure, are listened to and feel valued. Safeguarding Children and the pastoral care of all our pupils is our first priority, and our child protection policy clearly reflects this commitment.

Two Mile Ash School is aware of and compliant with multi-agency child protection procedures that have been agreed locally through MK Together Partnership which are based on statutory guidance Working Together 2015. TMA's Child Protection Policy and other key documentation are published on the school website for your information.

Two Mile Ash School has clear guidelines for monitoring children at risk and we make use of the curriculum to build preventive approaches to child protection.

The Headteacher and the Leadership Team are the school's Safeguarding Leads and there are clear procedures and lines of communication which enable the school to work closely with parents and other agencies.

In cases where it is considered to be in the best interests of the child, the policy requires the Safeguarding Lead to refer such cases to the investigative agencies.

Pupil Support

At Two Mile Ash, we are very much committed to an inclusive approach to your child's education. We believe very strongly that children of all abilities should be catered for – allowing them to reach their full potential and feel a sense of achievement in the process. We feel that all children should be given as diverse an education as possible and that this should not be hindered by their academic ability, or SEND needs.

Under the SEN Code of Practice we cater for children under the four areas of SEN: Cognition and Learning, Communication and Interaction, Social, Emotional and Mental Health Difficulties and Sensory and Physical Needs. Every child on the Special Educational Needs register has provision and outcomes directly tailored to the individual. We welcome full collaboration between the Pupil Support team, teachers, parents and the child to ensure that the children are successful within Two Mile Ash.

If your child has very specific needs, then we may have to take this process a step further and request the support of outside agencies. However, this will only be after consultation with you, as parents. We very much believe that it is only with direct support and regular communication between school and parents that the child will achieve the outcomes set. If you have any concerns, then please come in and share these with us. Our doors are always open.

Our aim is to ensure that children experience a broad and balanced curriculum. We will endeavour to ensure your child has all the rich experiences of the Two Mile Ash day while simultaneously having direct support in their outcome areas.

Within school, we offer an extensive range of provision undertaken by Learning Support Assistants and our Specialist Pupil Support Team. This team also works with children and parents to support children socially and emotionally in school in order to increase their confidence, self-esteem and help nurture peer interaction. Most Able

Our key aim is to provide most able children with opportunities to develop specific skills or talents and to work at higher cognitive levels. Children are placed on the most able register and this is reviewed regularly, adding any children we feel are 'gifted' in any subject area. Throughout the curriculum, every teacher differentiates the work and provides appropriate extension and enrichment activities to extend and inspire our gifted children. As with all areas of school, full collaboration with teachers, parents and the child is paramount to securing the child's success.

English as an Additional Language

As a whole staff, we work very hard to create an environment that respects the range of languages and cultures of our local community. We believe that providing the correct support for children with English as an additional language (EAL) and, where possible, nurturing their mother tongue is essential. We understand that the quicker the child's needs are identified, the sooner the child's learning is built upon and confidence grows. Our job is not only to support the learning of the English language and help access the curriculum but for pupils to independently converse and build positive relationships with their peers.

Pupil Premium

In England, all children in Foundation, Year 1 and Year 2 can receive school meals at no cost to you. This is a universal entitlement for all infant aged children. In addition, every child whose parent is receiving one of the following welfare benefits listed will be eligible for Pupil Premium funding. This is extra money for the school, provided by the government, to pay for targeted support for learning.

Entitlement to Free School Meals for children in school in Year 3 and above is not universal. You will need to make a separate application and your eligibility will be dependent on the benefits that you receive.

What are the new eligibility criteria?

Children are entitled to receive free school meals if they or their parents or guardians receive any of the benefits below.

- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)

 Working Tax Credit run-on - paid for four weeks after you stop qualifying for Working Tax Credit

Section 4 – Our Meal Provisions

School Meals

We are proud that our in-house catering department offers good quality lunches at affordable prices. Our meals are very popular and are constantly reviewed as part of our Healthy Schools Initiative to provide tasty, healthier options which meet government standards. Hot meal options with a pudding are available at lunchtimes as well as a cold packed lunch option. Fresh fruit, bread and salad sides are available every day. There is a current 2019-2020 set price of *£2.30 per meal (* prices are subject to review and may change at the start of each new academic year). Please note that we offer the option of meals being Halal and non-Halal. Should you require details regarding Allergens, this information can be found on the School Website under Parents/School Meals.

Menus are available online at the beginning of each term and orders should be **pre-booked by the Wednesday of the previous week** via our online payment system ParentPay www.parentpay.com (log in details will be provided).

Children may also bring their own healthy packed lunch to be eaten under supervised conditions.

Break Time Tuck

Section 5 - Extended Schools

Extra-Curricular Activities and Extended Clubs

Two Mile Ash offers a comprehensive extra-curricular programme for all pupils who wish to participate. Extra-curricular activities run after school from 3:30pm – 4:30pm. These clubs are run by staff at Two Mile Ash.

Every term we have a variety of clubs on offer. These include clubs such as design technology, arts and crafts, science, dance, orienteering and more. We also offer our range of sports clubs each term.

A small charge is made for administrating extra-curricular clubs. Parents are always notified of these well in advance via the club programme letter.

We also offer our extended club programme. These are our unique clubs on offer to our children and run differently to the extra-curricular programme. These clubs include activities such as skiing, snowboarding, karate, badminton, music lessons and more. The extended club prices vary depending on the club on offer. If your child signs up for one of these clubs, it is the parent's responsibility to collect their child from school and transport them to and from the venue of the club. The extended clubs are run by their own coaches and are held at various venues including Two Mile Ash School.

Dismissal After Clubs

At the end of each school based club (4:30pm), the teacher will take the children onto the slope where they will wait for parental collection. May we remind you that prompt collection from clubs is expected.

Educational Visits

We provide a full range of off-site learning opportunities and place a high importance on out-of-the classroom learning, particularly residential visits. We offer a residential visit in each of the 4 years; Year 3 Youlbury, Year 4 and 5 activity centre visit to Whitemoor Lakes, Year 6 Belgium.

Parents are given full notification of all visits well in advance but in the event of a parent not wishing their child to take part in a curriculum term time visit, arrangements will be made to accommodate their child in school.

Parents are asked to note that governors have made a bursary available to the Headteacher to assist parents who may wish their child to take part in certain visits, but who may be experiencing difficulties in making a financial contribution. Please inform the Headteacher if you require any assistance.

All visits conform to very precise safety procedures, as detailed in the school's comprehensive Educational Visits and Off-site Learning Policy, which is available upon request, for inspection by parents. Visits are reviewed and updated at the end of every academic year and we hold an Educational Visit Information Evening early in the autumn term.

Charging & Remissions Policy

The school has adopted DFE guidelines in establishing its policy on charging for educational activities.

The policy is as follows:

- 1. Where activities take place during school sessions, parents should be invited to make voluntary contributions towards the cost of the activity on a pro-rata basis, but a pupil should not be prevented from taking part in that activity because his or her parents cannot make a contribution. (In the event of insufficient financial support being provided to meet the expenses of a particular activity, the activity may have to be withdrawn).
- 2. Where activities take place outside normal school sessions, charges should continue to be levied as appropriate.
- 3. The Headteacher must be consulted if a parent wishes to make an application for full or partial remission of charges.
- 4. Charges can be made for materials where parents have indicated in advance that they wish to own their child's finished work.
- 5. Parents will be asked to meet the cost of breakages or damages where these are the result of inappropriate behaviour on the part of their child.



Wrap Around Care – Two Mile Ash Kidz Club, Breakfast, Afterschool & Holiday Care

We recognise the importance of supporting our parents and are pleased to offer 'wrap around care' for our children. In order for us to offer these facilities, we do need to charge parents, however, we aim to keep costs fair and affordable and provide a safe, secure and fun environment for our children.

The Breakfast and Afterschool Clubs below are available for those parents of children in Years 3, 4, 5 or 6, who wish their children to be supervised in school between the times stated. Our Holiday club is available to all members of the public whose children are aged between 5-13.

Breakfast Club – Term Time Only

We offer a comprehensive Breakfast / Early Morning Care Club from 7:30am – 8:30am every morning. Pupils can arrive from 7:30am to 7:50am for breakfast, before starting activities at 8am.

- Full payment must be made and booked online.
- All bookings are handled on a first come, first served basis.

Liaison with Parents

We look forward to getting to know you and working in partnership with you, to ensure your child's life at Two Mile Ash is positive, productive and enjoyable. We would like to reassure you that, if at any time you want to talk about your child's progress or have any concerns, we operate an 'open door' policy. So please do not hesitate to contact the school.

At Two Mile Ash we strongly and warmly encourage parents to take an active part in school life in a number of ways:

- Helping in the classrooms or in the school in general.
- Supporting school fundraising events through generating new ideas and where possible offering help during an event.
- Attending curriculum workshops.
- Encouraging and supporting your child with home reading and Independent Study.
- Helping with after school clubs and activities.
- Providing the appropriate games and PE kit, clearly named.
- Attending Parents Consultation Evenings.
- Jointly supporting your child through times of difficulty and also sharing in the enjoyment of your child's successes.
- Ensuring all contact details including email, home address and telephone numbers are up to date.

To keep you up to date with school life, there is a Headteacher's newsletter that is published at least twice every half term and parental contributions to the newsletter are welcome. Newsletters are sent out electronically by ParentPay and can also be found on our school website.

Our school website is truly a window into our school and offers both a place to seek key information as well as sharing events and news with the community. We are incredibly proud of our children's achievements and are pleased to share these on Youtube, Twitter and Facebook. To enable all pupils the opportunity to share their achievements in such a way, we require photograph permission. Please ensure the permission form is returned to Two Mile Ash prior to July 19th. If you have any concerns regarding your child's photograph, please do not hesitate to contact us.

As with everything we do at Two Mile Ash, it is essential that we work closely with parents. We hope you enjoy your time at Two Mile Ash and thank you in advance for all your help and support in our partnership. It is both greatly appreciated and needed.





Reporting to Parents

Our Home-School relationship, which is of such integral importance to the school, is especially dependent upon effective communication. We believe that a child will prosper best only if there is strong liaison and a high level of understanding between home and school.

Two Mile Ash's reporting strategies have proven to be extremely successful in fostering this level of understanding, and parents place much value upon the efforts the school makes to keep them informed of their children's progress at regular intervals throughout each year.

Two "formal" Parent Consultation evenings take place each year. During this time, parents meet with their child's class teacher to discuss progress and establish new targets. The final invitation at the end of the summer term, is a celebration evening where we recognise the achievements of the year.

Parents may, of course, consult with staff at any time regarding their child's progress and the school very much encourages this flexibility.

We provide a comprehensive written report on every pupil at the end of the summer term, which is emailed to parents. This annual report contains a commentary on progress in each of the National Curriculum subjects and pastoral development. Strengths and special achievements are highlighted along with specific targets for future development and parents are encouraged to comment upon the year's progress also.

Standard Assessment Test Results (SATs) are reported on in Year Six, when each child's actual level of attainment in English and maths are reported. Comparative information of the overall results of children in the same Two Mile Ash year group, as well as the previous year's national results, are also presented at this time.

Home Learning (Guidelines for Parents)

At Two Mile Ash we believe Home Learning - Independent Study - should be purposeful, enjoyable for the child and stimulate imagination and creativity as well as reinforce what is taught in the classroom.

Independent Study provides an opportunity for our children

- To become independent and curious learners.
- To develop good study habits.
- To build up essential skills in literacy and numeracy.
- To prepare for the next stage of education.
- To encourage parental interest and support in children's learning.
- To consolidate and reinforce what is taught in the classroom.

Throughout their time at Two Mile Ash, all children will be expected to complete Home Learning each week. Dependent on their year group, this could include:

- Daily reading with discussion based around comprehension to a parent/carer;
- Weekly spelling
- Grammar activities;
- Weekly times tables practice (through Times Tables Rockstars app)
- Maths activities to consolidate learning in the classroom;
- Learning Journey projects.

Parents are asked to support and encourage children with their Home Learning. However, if your child requires further support, please contact the child's teacher.

Home Learning will be collected and monitored on the same day each week and teachers will assess and feedback to the children.

A record will be kept of the pupils' progress and commitment to Home Learning.

Children who fail to complete Home Learning on a regular basis to the best of their ability will be monitored closely by staff who will inform parents/carers as soon as they feel an issue may be arising.

Home Learning support facilities

Children will have the opportunity to attend after school Home Learning club where they will be in a peaceful, supervised environment at the end of the school day. They will have access to reading and reference books and the ICT facilities to support their work.



Attendance & Absence from school

Absence from school significantly impacts on a child's self-esteem and ability to make progress in their learning and to that end, we endeavour to ensure every child has an excellent attendance record. Our target for attendance is 97%.

For all concerned, it is extremely important that we know why a child is absent from school. Parents are asked to telephone school as soon as possible on the first day of absence and to continue to inform the school on each day thereafter for the duration of the illness. To support with this, we have a messaging system that can be used by phoning into school on 01908 562262.

Due to changes in government guidelines, schools are no longer able to authorise requests for holiday periods during term time. Any parent whose child misses up to 10 sessions (1 day equates to 2 sessions) may be subject to a formal fine process. Further details of leave of absence and attendance matters can be found in the school attendance policy on the website.

If you have any queries regarding your child's attendance, please contact the school attendance officer.

Since August 1992, schools have been required by the Department for Children, Schools and Families to include information on rates of authorised and unauthorised absence in their prospectus and annual reports.

Key Stage Two Results 2019

As a parent, you will naturally be interested in how well Two Mile Ash is performing as a School in relation to government strategy and targets set for the primary school sector.

There have been numerous changes to assessment procedures, leading to challenging circumstances, with an ever-changing assessment landscape that Year 6 have had to work within over the last few years.

We have worked hard as a whole school community to ensure our children are prepared for the challenge of testing and are always proud of their results. Our results are very high compared to the National figures which is a continuing trend. As you would expect, across the whole school, we are very proud of the hard work and positive commitment our children have demonstrated in their learning.

Complaints Procedure

An excellent relationship exists between the school and its parents. Staff have earned a reputation for being very approachable and for being good listeners.

Two Mile Ash parents are positively encouraged to come into school to talk about any aspect of their child's education. Initial contact is usually made through the child's class teacher, and in the vast majority of cases, concerns or anxieties are usually resolved at this stage. However, if a parent wishes to make a formal complaint, the governing body has published guidelines for parents detailing the necessary stages in the formal complaints procedure. These are as follows:

- 1. The first point of contact
- 2. The first stage in the formal procedure
- 3. The second stage in the formal procedure
- 4. Direct appeal to the Secretary of State

Formal complaints must always be addressed to the Head teacher in the first instance. If after having contacted the Head teacher you still feel dissatisfied and the complaint is still there, you may wish to proceed to the formal complaint procedure, (under section 23(1) of the Education Reform Act.). Parents should send their complaint, in writing, to the Chair of Governors.

The Chair of Governors will register all relevant complaints and make arrangements for the complaint to be considered by a sub-committee of the Governing Body or where appropriate by the entire Governing Body. You may then make representation in person to the Governors and you will then be given seven days-notice of the hearing of the complaint. A written report will be sent containing the information on the decision taken and the reasons for it. Any action taken, or proposed, including details of any request made to those complained against to take particular action to resolve the complaint, will be made known. Further recourse is available if you are not satisfied with the decision.

A copy of section 23(1) of the Education Reform Act 1988 is held in the school, copies of which are available on request.

The school places enormous value upon its supportive relationships with its parents, and we earnestly ask all our parents not to hesitate in letting us know about any matters of concern.

The school will always respond positively to constructive advice that is offered in a sensitive and understanding manner, and we genuinely welcome such comments when presented in this way.

Section 7 – Initial Teacher Training and Teaching School

Two Mile Ash ITT Partnership





The Two Mile Ash Initial Teacher Training Partnership has been accredited by the Department for Education as a provider of initial teacher training. Over the 16 years that we have been qualifying teachers, over 500 teachers have been supplied to Milton Keynes schools. We were proud to have been recognised by Ofsted in March 2013 as an 'Outstanding' provider of initial teacher education. We developed our programmes further in 2014 to offer a PGCE with QTS and then in 2018 we became the first school-based teacher training provider in the country to offer a 3-year BA Hons undergraduate route into teaching (currently offered in conjunction with Birmingham City University).

We work with nearly 50 schools across Milton Keynes and its surrounding areas. All our schools are fully committed to their involvement in initial teacher training, highlighting the contribution student teachers make to their schools as a significant benefit. The presence of student teachers encourages reflective practice within the school, promotes greater collaboration of professionals both within and beyond their own school environments and ensures all teaching is at the forefront of developments within education. Our experienced practitioners also value what they can learn from the inexperienced trainees: whether it is something of the latest ideas and techniques in teaching or re-energised enthusiasm for the traditional methods.

Above all, we feel that passionate, enthusiastic student teachers have a great impact on our pupils. The children build excellent relationships with them and form lasting fond memories of the time they have spent with them.
